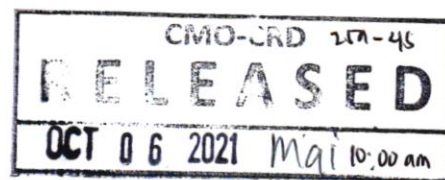

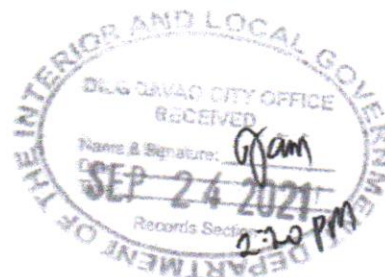

Sa isang pag-aaral na isinagawa ng *Philippine Institute for Development Studies (PIDS)* na kinomisyon ng *UNICEF Philippines*, ipinapakita na wala sa kamalayan ng mga barangay ang *Philippine Plan of Action for Nutrition (PPAN) 2017-2022* bilang balangkas sa pagtugon sa mga suliraning pangnutrisyon sa antas ng barangay. Ang katulad na resulta ay napatunayan din sa isinagawang *recall survey* ng *EON Group*, kung saan natuklasan na hindi pamilyar o kilala ang PPAN sa lokal na antas.

Dahil dito, ang pagpapayoridad at pagpapalano ng mga lokal na programa sa nutrisyon ay apektado. Ang kaliitan ng badyet para sa nutrisyon ng barangay ay isa ring paulit-ulit na isyu. Nakikita lamang ang nutrisyon bilang usaping pagkain at pagpapakain sa mga bata.

Kaugnay nito, ang Pambansang Sanggunian sa Nutrisyon o *National Nutrition Council (NNC)* ay magsasagawa ng *Virtual Dialogue with Punong Barangays: Enabling Nutrition Devolution* sa Oktubre 4, 2021 upang:

1. Itaas ang antas ng pagkilala sa PPAN at kaugnayan nito sa mga *barangay nutrition action plans (BNAP)*;
2. Tukuyin ang mga gawain ng *barangay nutrition committee (BNC)* at mga tungkulin ng mga Punong Barangay, mga *Barangay Nutrition Scholar (BNS)*, at iba pang mga miyembro ng komite sa pagkamit ng mga target ng BNAP at PPAN;

3. Tukuyin ang mga magagandang kasanayan ng mga mahuhusay na BNC sa pangangasiwa ng mga programa sa nutrisyon na maaaring magamit sa kani-kanilang mga barangay;
4. Ipaliwanag ang mga implikasyon ng *Supreme Court Ruling on Mandanas-Garcia Petitions* sa pangangasiwa sa mga programa sa nutrisyon sa mga barangay.

Bilang pakikiisa sa layuning mapagbuti ang kaalaman sa nutrisyon at PPAN sa antas ng barangay, inaanyayahan ng Kagawaran ito ang lahat ng mga Punong Barangay sa bansa na makilahok sa nasabing dayalogo na gaganapin sa **ika-4 ng Oktubre, taong 2021 sa ganap na 1:00 hanggang 5:00 ng hapon.**

Nakalakip dito ang *Program of Activities* para sa nasabing dayalogo para sa inyong batayan. Mangyaring kumpirmahin ang iyong pagdalo hanggang ika-1 ng Oktubre, taong 2021 sa <https://tinyurl.com/NutritionDialogue2021>.
